Contract attribution for the collection of residential solid waste: K1 collection Territory.

WHEREAS the Board of Directors of the Kent Regional Service Commission adopted the 2015-065 motion to move forward with the optimized collection system;

WHEREAS Baie-Sainte-Anne, Escuminac, Hardwicke, Shediac-Bridge, Shediac-River and the Notre-Dame section of Westmorland County were added to the optimized collection system through the 2024-008 motion;

WHEREAS the Commission launched the call for tenders for the K1 collection territory on July 29th for the intended services;

WHEREAS a total of one (1) proposal was received for the call for tenders # 2024-07-29-K1;

Here is the selected proposal:

Fero Waste & Recycling Inc. for the sum of \$5,249,029.50 for six (6) years excluding HST:

- > \$838,927.43 for year one (1) of the contract (14 months)
- > \$832,755.21 for year two (2) of the contract

Recyclables collection - Baie-Sainte-Anne, Escuminac and Hardwicke

WHEREAS responsibility for residential waste collection in the communities of Baie-Sainte-Anne, Escuminac and Hardwicke has been awarded to the KRSC by the Department of Local Government;

WHEREAS the contract in this region will not expire until December 2024, and the new K5 contract will therefore begin on December 29, 2024;

WHEREAS responsibility for the collection of recyclable materials in this region will pass to the KRSC as of November 3, in order to meet the schedule set up by Circular Materials;

WHEREAS as a result, the KRSC must enter into an agreement with a collection company to ensure continuity of recyclable materials collection service in these communities in November and December 2024;

WHEREAS the employees of the KRSC have contacted the company M Gaudet Garbage, which currently offers the collection service in these areas, to ask them to submit a price for the collection of recyclable materials in these communities four times between November 3 and December 28, 2024.

f. Regional Transportation

The stickers have been placed on the van, which has been in use since the end of July. It's a service that works well and is much appreciated by clients. An official launch will take place in October. Details to follow.

g. Recreation Planning

Claudie Ringuette announces that the Saint-Louis-de-Kent pool will resume activities in October. A press release will be issued shortly, and swimming classes will resume with a new schedule to accommodate out-of-towners. They are currently interviewing for lifeguard positions.

Claudie mentions that funding has been received from the RDC to enable a preliminary study to be carried out for the trails. She also mentioned that the 2024 Trails Summit, organized by Recreation Loisirs NB with the support of the Department of Tourism, Heritage and Culture, is taking place in Bouctouche this year, on September 18th and 19th. Two key people came to give a short presentation to the Board of Directors. Ms. Lynn White, Director of Tourism Development with the Department of Tourism, Heritage and Culture, explained that they develop tourism in different sectors in the province. She talks about the funds that might be available to develop motorized and non-motorized trails. As for Rob Neish, Trail Development Officer, he mentions several organizations/associations they've worked with to create or develop trails throughout New Brunswick. They're there to support every step of the way, whether it's putting us in touch with different resources, providing the information needed to fill out a funding application, supplying data, guiding and giving advise throughout the process.
