d. Economic Development and Tourism

The 2024 Kent Entrepreunarial Gala will be held in Grand-Bouctouche on Saturday, November 2nd. The evening will feature the launch of the new employee retention and recruitment website for the Kent region.

e. Community Development

The committee met on September 26th, but had only notes of the previous meeting, so no minutes to submit to the Board at this time.

Stéphanie Caissie mentions that over the summer they worked on the mandate and terms of reference simply to ensure that the regional strategy plan was presented in the mandate. And also to ensure that there was better representation of certain sectors that were mentioned in the strategy. Stéphanie Caissie introduces Chantal Vautour, who will be in charge of the Champions Kent project.
