## Subject: Proposal to close redundant bank accounts to simplify and optimize financial services.

WHEREAS several bank accounts have been opened for different services offered within our organization; WHEREAS the high number of bank accounts generates recurring fixed costs such as management fees, service fees and maintenance fees, which increase expenses without adding value;

WHEREAS modern technology and online banking now make it possible to group several services under a reduced number of accounts, making it unnecessary to multiply accounts for each specific service;

WHEREAS centralized management of bank accounts would simplify accounting, better track financial flows and maximize the use of available resources;

WHEREAS reducing the number of bank accounts also reduces the risks associated with managing financial information and transaction security.
